These guidelines are provided to describe categories, fees and requirements. Any applicant not meeting necessary requirements will be ineligible to participate in TNMP.

### **FOOD VENDORS**

- All food vendors within the BID (see BID map), will pay 10% of their nightly gross sales, with a minimum rate of \$60.
- Food vendors located outside the BID (see BID map) must be approved and will pay 10% of their nightly gross sales, with a minimum rate of \$70. Business shall be determined not to be similar, related, and/or a competing business with any business or organization that is a BID member and a participant in the Thursday Night Market Place.
- Must supply a copy of:
  - Application
  - Liability insurance (1 million dollar general aggregate) with Main Street Hanford listed as an “Additional Insured”
  - Health Department Permit (contact number 584-1411).
  - City of Hanford Business License (Can be obtained at 315 N. Douty Street.)

**Note:** Vendors needing more space than the assigned 10ft x 10ft, will need approval and will be charged an additional \$20.00/night per 10ft x 10ft.

### **CERTIFIED GROWERS**

- All certified growers will pay 10% of their nightly gross sales, with a minimum payment of \$20.00/night. If a certified grower earns less than \$200.00 on any given night, they must pay the minimum payment of \$20.00/night.
- Note: Growers paying for an additional space for \$20/night will need approval and will be charged an additional \$20.00/night (minimum of \$40.00/night).
- Must supply a copy of:
  - Application
  - Liability insurance (1 million dollar general aggregate) with Main Street Hanford listed as an “Additional Insured”
  - Certified Produce Certificate

## **ALL OTHER VENDORS**

### **MEMBERS/\$30**

- Must be a business in our Business Improvement District (BID). See BID map.
- Must supply a copy of:
  - Application
  - Copy of Business License
  - Signed Vendor Release of Liability form
  - City of Hanford Business License (Can be obtained at 315 N. Douty Street.)

### **NON-MEMBERS/\$40.00**

- Business shall be determined not to be similar, related, and/or a competing business with any other vendor/participant.
- Must supply a copy of:
  - Application
  - Signed Vendor Release of Liability form
  - City of Hanford Business License (Can be obtained at 315 N. Douty Street.)

### **NON-PROFIT/\$30.00**

- One free space per night, per non-profit. Must be reserved at least two weeks in advance. Additional spaces may be available for \$30/night upon approval.
- Must supply a copy of:
  - Application
  - Signed Vendor Release of Liability form
  - Must supply a copy of non-profit status from the IRS

### **MAKERS-CRAFTERS/\$30.00** Must supply a copy of:

- Application
- Signed Vendor Release of Liability form
- Photos of items to be sold
